**Capital Improvements** 

The Arroyo Roble Resort has completed most of the budgeted capital expenditures for 2019 and the results are beautiful. Completed projects include:

- Three (3) new fountains around the property. One in the central courtyard and one each in the parking area of the 1100's and 1300's buildings. The fountains are truly beautiful and give our homeowners and guests a wonderful ambience.
- New sidewalk lighting throughout the resort has increased the nighttime safety and gives a lovely look in the evening hours. New lighting includes the area of the Creekside deck and bridge areas as well.
- New fireplace inserts have been installed in 24 villas and the project is anticipated to be completed in 2020. The new units are self-contained and only require a turn of the timer dial to enjoy the fire.
- The Arroyo Roble Resort is now happy to announce that we have 5 exterior stair-lifts on the single level villas! This gives our homeowners access to an additional 5 villas that are on the single level for ease of movement. While the upper single level villas are NOT ADA accessible units, the access to these units is more easily accomplished by the use of the stair-lifts if you have mobility issues with stairs. Please discuss with Debra in reservations for additional information.
- We have also completed the refreshment of the pool area as well. The waterline pool tiles have been replaced and we have a brand new pool deck treatment which upgrades the look and safety of the entire area.

City of Sedona notification:

June 3 - Uptown construction begins

SEDONA, Ariz. -- The first major Sedona in Motion construction project begins in Uptown Sedona on Monday, June 3. The work will last 9-12 months. The contractor expects to maintain two-way traffic on SR89A throughout the project. The Jordan Road intersection will be closed to through traffic at State Route 89A during construction hours. Northbound motorists are asked to follow the marked detour along Forest Road, Van Deren Road, and Mesquite Avenue. Southbound motorists will be directed to Apple Avenue. Detour signs and blue business access signs will be visible to guide traffic. Please be aware of lane restrictions, reduced speeds, and flagging operations.

The city is also making a special effort to accommodate and assist Uptown business owners during construction by distributing fliers door-to-door, partnering with the chamber of commerce on special promotions, and in other ways that are described in the Business Construction Support Guide posted on the <a href="mailto:sedonachamber.com">sedonachamber.com</a> website.

**About the project.** This project -- the Sedona in Motion Uptown Roadway Improvements project -- will improve traffic flow, and the appearance and community feel of Sedona's Uptown area through a combination of street, hardscape and landscape improvements. Project elements have been designed to control traffic flow and remove a variety of causes of slow-downs. Included in this project:

 Decorative raised median to direct pedestrians to controlled crossings and enhance the appearance of Uptown.

- Addition of a southbound SR89A travel lane.
- Turnaround points at the north and south ends of Uptown, including a Jordan Road roundabout.
- One-way access from 89A to free parking via Schnebly Road.
- Pedestrian control and signal timing improvements at the intersection of SR89A and Forest Rd.

# **Smoking Policy!**

A gentle reminder for all our homeowners and guests about the smoking policies here at the Arroyo Roble Resort. We follow all State of Arizona and Federal laws pertaining to smoking here at the Arroyo Roble Resort. There is NO smoking allowed in any building of the resort at any time. This includes cigarettes, vaping products, and all medically prescribed marijuana products of any type. If you do smoke in the villas at any time or within 20 feet of any entrance to any building of the property, you will be liable for additional cleaning charges which average approximately \$150 to \$300 dollars depending on the severity of the cleaning process required for the villa or building. Additionally, there is absolutely no smoking anywhere in the pool area of the resort – either inside or outside. Please be considerate of your fellow homeowners and follow the rules and regulations.

## **Service Animals!**

Federal Law requires the Arroyo Roble Resort to accommodate service animals as defined by law. Please do not attempt to bring your personal pets to the resort as they do not fulfill the federally mandated requirements of training and specialization. If you do arrive with a trained service animal please notify the front desk immediately upon arrival or you may be asked many times during your stay about the legality of the service animal. Please also be aware that you are required to clean up after your animal. If you do not, you will be responsible for additional costs payable upon departure of your stay.
