## **ISSUE TO BE DECIDED**

The general membership will elect <u>two</u> directors from the slate which has been presented by the Nominating Committee. The candidate receiving the highest number of votes will serve a three-year term. The candidate receiving the next highest number of votes will serve a two-year term.

#### **BALLOT INSTRUCTIONS**

There are two (2) vacancies to be filled. There are two (2) votes for each timeshare interval owned (one for each board vacancy). The Bylaws (Article VII, Section 2) stipulate "Each member entitled to vote shall have the right in the election of directors to cumulate his votes."
