ELECTION ISSUE TO BE DECIDED

There were two additional homeowners willing to run for a position on the Board of Directors for the 2024 Election in addition to two incumbents. Therefore, per the CCR's for this year's election, the candidate receiving the highest number of votes will serve a three-year term. The candidate receiving the next highest number of votes will serve a two-year term.

BALLOT INSTRUCTIONS

There are two (2) vacancies to be filled. There are two (2) votes for each timeshare interval owned (one for each board vacancy). The Bylaws (Article VII, Section 2) stipulate "Each member entitled to vote shall have the right in the election of directors to cumulate his votes." This means you may cast all your votes for one candidate or split your votes in any way you choose, so long as you do not cast a total of more than two votes per interval owned. To emphasize this point, if you own 1 interval, you have 2 votes. If you own 3 intervals, you may cast 6 votes, etc.
